Proposed Transportation/Bell-Time MOU

While we have not received a complete District response to our September 2 correspondence, we provide the following as our initial BTF response to your proposed MOU. Of obvious interest is a complete delineation (the specifics) of the plan which neither we nor the parents have received. Enclosed please find copies of District proposals presented to us during negotiations and a copy of our current contract.

You will note that your first proposal was dated September 25, 2019 and that there were no specific proposals until 3/17/22 and 4/28/22.

Also, there was no follow-up on this issue from 4/28/22 until your proposed MOU on September 1, 2022.

Some specific issues:

The proposed contract changes remove the current "For the 2018-2019 school year (July 1, 2018 to June 30, 2019) only" and replaces it with "the District may change the starting and ending time at schools to accommodate savings on bus routes."

In other words, any time the District chooses to change starting/ending times, it can, as long as it "says" it is to save money on busing. Whether it is in the best interest of schools, parents and staff is not a factor.

In addition, your September 1, 2022 MOU substantially increases what your 3/17/2022 and 4/28/2022 proposals demand of teachers, i.e. from your MOU:

• For this year only, provides teachers "with 30 days' notice of any proposed change in a school's bell time" instead of as per your contract proposals, notification by January 1st.

- The MOU changes your contract proposal (and the current contract) from "the starting time shall begin <u>no earlier than 7:50 am</u> and end <u>no later than 4:05 pm"</u> to "the starting time shall begin <u>no earlier than 7:30 am</u> and <u>end no later than 4:45 pm"</u>.
- Your MOU <u>removes</u> from your contract proposals (and the current contract) "iii Unless agreed to
  by the faculty of the affected schools, no other changes within the starting and ending times will
  occur."
- Your MOU removes from your contract proposals (and the current contract) IV. "Starting and/or ending time changes will be no more than one (1) hour."

#### Some Issues:

- How do you expect parents and teachers to change their childcare and their similar responsibilities on such short notice?
- How will after school programs function?
- Buses now sometimes don't arrive back at the student's home until 7:00 pm (especially in winter). The buses would then arrive forty (40) minutes later.
- Students would be waiting for their bus in the dark twenty (20) minutes earlier. Some students who did not have to wait for buses in the dark will now have to wait in the dark.
- What happens if parents have, for safety or other concerns, enrolled two (2) of their children at two different early schools only to find that one of the schools is now a late school?

Not only have you delayed negotiations for three (3) years, requiring the BTF to file three (3) improper practice charges against you, presented insulting and demeaning contract proposals, delayed until October 7, 2022 Fact Finding that you proposed and for which a Fact-Finder was appointed in <u>August</u>, you now propose an MOU that imposes conditions far beyond those in your contract submissions. **You have also not even delineated, and detailed what you expect parents and teachers to support. Unfortunately, what else is new?** 

We await your response to this correspondence, so that we can <u>all</u> come to agreement on <u>all</u> the important issues before us.

The BTF is taking legal action on the above.

#### Memorandum of Understanding

#### The Buffalo City School District

#### And

#### The Buffalo Teachers Federation

# Re: Transportation/Bell-Time MOU

This Memorandum of Understanding ("MOU"), dated and effective as of the last date executed below (the "Effective Date"), is by and between The Buffalo City School District (the "District") and The Buffalo Teachers Federation ("BTF"). The District and the BTF are referred to jointly as the Parties.

WHEREAS, the terms and conditions of employment for teachers are established in a Collective Bargaining Agreement ("CBA") between the parties dated October 17, 2016.

WHEREAS, during the 2021-2022 school year, the District experienced the impact of the national bus driver shortage that, despite the best efforts of the District to mitigate the issue, impacted its ability to get students to and from school in a timely, safe manner and impacted its ability to offer the wide array of programming our students need, such as after school programming.

WHEREAS, the District expects the national bus driver shortage to continue to impact its transportation programming during the 2022-2023 school year.

WHEREAS, in anticipation of this continued crisis, the Superintendent directed the convening of a Transportation Committee that included many stakeholders including District staff, community and parent leaders, and union leaders that met throughout the summer of 2022 to make recommendations to the Superintendent to address the crisis.

WHEREAS, one proposed solution from the Transportation Committee is the implementation of a three tiered bell time schedule that would reduce the need for up to 100 drivers and effectively solve the transportation crisis.

#### NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

- The Parties mutually agree to the following amendment to Article VIII(A)(1): Modify the current language to delete "For the 2018-2019 school year (July 1, 2018 to June 30, 2019) only," such that the language will read "The District may change the starting and ending time at schools to accommodate saving on bus routes under the following conditions:
  - 1. Teachers will be notified in writing of any such change on or before January 1st of the year in which the change will take effect (e.g. notice must be provided on or

before January 1, 2023 for a change to take effect for the 2023-2024 school year); For the 2022-2023 school year only, the District shall have the ability to make bell times changes during the school year provided it inform teachers with 30 days' notice of any proposed change in a school's bell time.

- ii. Upon notification of said changes, teachers at the affected schools will be placed at the top of the transfer list for the upcoming school year based on their seniority;
- iii. For the 2022-2023 school year only, in the event that a change in bell schedule creates a legitimate hardship for a teacher, he/she may apply for a hardship transfer, which will not be unreasonably denied.
- iv. The starting time shall begin no earlier than 7:30 a.m. and end no later than 4:45 p.m."
- 2. The parties agree to amend lines 20 and 21 in Article VIII(A)(1) to state, "The starting time shall begin no earlier than 7:30am and end no later than 4:45pm.
- 3. This agreement shall not be construed by either party as modifying the rights of the parties under the CBA between the parties, except as specifically set forth above, nor shall it constitute a precedent or practice with regard to any other matters.
