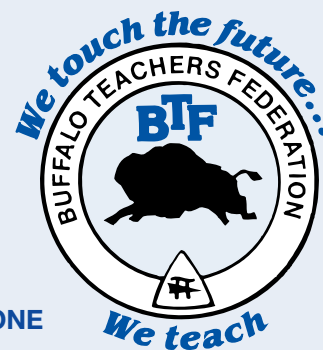

## A Constitutional Convention Could Eliminate Rights, Benefits of Public Employees

Every 20 years, the people of New York State are asked a simple ballot question;

“Shall there be a convention to revise the constitution and amend the same?”

Most people in New York State aren't even aware, according to a recent poll, that the state has its own constitution, let alone a clause permitting a convention to amend it.

The question, which will have a huge impact on not only BTF members, but every citizen of the state, will appear on the ballot on November 7, 2017.

At risk, if the convention is held, are pensions for public employees, rights to be a member of a union and bargain collectively and public employee benefits. Other states have already removed these rights from their constitutions.

### Lengthy Process

If the voters agree to hold the convention, it will meet in Albany in April 2019 for an unspecified duration. The delegates will deliberate and publish their suggested amendments.

Proposed changes are then submitted to the voters, either individually or as a group – as done in 1967; and another public referendum vote will be held after the adjournment of the convention.

This convention process has been used nine times (1777, 1801, 1821, 1846, 1867, 1894, 1915, 1938 and 1967) to undertake major re-writes to the state constitution.

Some of these conventions succeeded with voters accepting the proposed changes, as in 1938, while other convention recommendations were rejected by the voters, as in 1967.

### What's At Stake

The constitution establishes a basic organizational structure for state government. Changes could be made that give too much power to one branch, for example say the executive. This

could unbalance power and weaken the legislature.

The constitution also establishes the fundamental rights of all citizens, particularly public employees, and retired public employees, including:

- Guaranteeing the right to a free public education (Article 11, § 1);
- Prohibiting reductions in public employee benefits (Article 5, § 7);
- Rights to workers compensation (Article 1, § 18);
- Rights to be a member of a union and bargain collectively (Article 1, §17);
- Requiring that the state provide for social welfare needs (Article 17, § 1).

### Actions By Other States

In other recent state conventions the rights and benefits to public employees were severely altered. They include:

- Alaska 2005 – Closes Teachers' Retirement plan; all new members in 401(k) style retirement plan
- Maine 2001 – Suspended COLA's for all retirees
- Mississippi 2010 – increased employee contribution rate for all employees from 7.2% to 9%
- New Hampshire 2011 – Place all new hires and non-vested employees in a new tier with lower benefits
- Rhode Island 2011 – Placed all new hires and all members with less than 20 years of service in new plan with greatly reduced benefits and higher employee costs

### Convention Delegates

If the convention is held, three delegates per State Senate District and 15 at-large delegates are elected at the next scheduled general election – 204 delegates in total.

These delegates can include sitting members of the state Legislature, political party leaders or other office holders. These delegates are allowed to hold both their

elected office and a position as a delegate; collecting both salaries.

### Cost to Taxpayers

**The cost of the convention, based on past conventions, is estimated in the hundreds of million dollars.**

Despite the cost and time involved, voters historically voted against most of proposed changes in previous years. In 1967, 72% of voters were against the proposed changes, compared to 27% in favor.

### What You Can Do

Everyone is needed to do their part in convincing voters that a Constitutional Convention is not in their best interest. 2017 is an “off” election year for the state Legislature as well as an “off” year for presidential voting, so voting should be minimal.

When the last convention was up for vote, many groups worked together to prevent it from happening.

These groups included:

- Public and private organized labor;
- Environmentalists and conservationists who did not want to see the repeal of the “forever wild” provisions that protect environmentally sensitive areas
- Advocates for public education at all levels
- Social welfare advocates who will seek to maintain the requirement that New York State provide for the underprivileged
- Fiscal conservatives who wanted to keep existing state and debt limits in place
- Some government watchdog groups who just didn't want to “spend the millions of dollars to hold a party in Albany!”

All these groups, plus others will need to work together again in 2017 to make sure voters understand just what could happen if we open up the state constitution to drastic changes through a convention.

## THE CHALLENGES NEVER END AND OUR RESOLVE WILL NEVER END

While we resolved a contract that begins to address the inequities between Buffalo teachers and our colleagues in other districts, old and new challenges are at hand.

### RECEIVERSHIP

The false labeling of schools (students, teachers, staff) based upon invalid student tests – tests that are given to students who speak little English, are in special Education programs, and who often care little about doing well on the tests, etc.

We will continue to fight the laws and regulations that give the power to override our contracts to implement changes that have nothing to do with improving the education of our students.

We are in court and working with NYSUT to overturn and eliminate this snake oil.

### APPR

Once again, while we were successful in putting the use of the standardized tests on hold until 2019, we have to continue the battle until we are evaluated based on our teaching by administrators who remember what

good teaching is – not an impossible standard that they couldn't have achieved in the classroom – assuming that they even taught in a city school for more than a short time.

Locally, while many administrators are complaining about the APPR process we worked out, we must seek to ensure that despite some administrators' dislike for the agreement, they follow it.

### THE TRANSFER PROCEDURE

Although the old transfer procedure was unacceptable, the new procedure was in many cases worse. We must continue to challenge any transfer policy that does not provide complete transparency relating to openings and process, that publically humiliates teachers and that does not provide teachers with knowledge of their position before the end of June (not September)

### FUNDING

The battle for more funding for our students from the City, State and Federal Government must continue.

### NATIONAL CHAOS

All eyes must be focused on the races for U.S. Senate and House of Representatives in 2018. We must be mobilized across the country to take back the Senate and House of Representatives. We need a barrier to prevent the destruction of education, the Supreme Court and all that most of us value.

Last but not least by far – we need to defeat the vote for a New York State Constitutional Convention. As you can read elsewhere in the Provocator, the defeat of this disruptive process is critical.

As you have heard me say many times before –

With our continued solidarity, we will meet and overcome each and every challenge we face. Why? Because we are Buffalo teachers who never, ever give up.

Bring them on!!

# Executive Committee Elections Make History

The Executive Committee elections, going green for the first time this year with on-line voting, held few surprises this year. A total of 746 electronic ballots were cast.

The top four officers were not challenged and most of the BTF endorsed candidates won or were re-elected to two - year terms.

**President Philip Rumore** was re-elected for an unprecedented 18th term.

Rebecca Pordum, who has served as Treasurer for the past three years, was elected Vice President.

Melinda MacPherson Sullivan, director of the Teacher Center, was elected Secretary and Joseph Montante, a Math Teacher at Olmsted #156 was elected Treasurer. Both have served on the BTF Executive Committee for many years.

Edith LeWin, who served as Vice President, and Kevin Gibson, who served as Secretary did not seek re-election.

The other results are as follows:

**PreK-6:** Sophia Howard-Johnson, Trisha Rosokoff, Chris Stephens, Rachel Binda –Lis, Janine Schuster and Ruyvette Townsend.

**7-12 Secondary:** Melissa Kenney, Lynn Garcia, Dennis Brancato, Eve Shippens, Patrick J. Foster, Chris Salamone and Sue Raichilson,

**K-12:** Mark Mecca, Isabella Keegan, Nicole Herkey, Gregory Sawicki Susan Baker, Elizabeth Spiro-Carmen and Catherine Lipsitz.

**At-Large:** Marc Bruno, Tom Gattie and Mike Mecca.

Balloting Occurred from May 8-22 and results were available instantaneously, eliminating the need to count ballots. Voters reported that the on-line voting was easy and convenient.

The Election Committee, which worked hundreds of hours to get the elections done were: Janine Williams, chairperson; Beth Ann Fullagar, James Healy, Angela Hester, Brian Hilton, Jorge Koury, and Temothye Peart.

## Rumore Calls On City Officials To Hike Student Funding

A letter calling the city's funding for Buffalo's students "disgraceful," has been sent by the BTF to Mayor Byron Brown and the Common Council.

BTF President Philip Rumore issued the letter May 9. It included charts that showed that the City of Buffalo's funding for its students was \$30,646,642 to \$93,151,509 behind Syracuse, Rochester and Yonkers.

The chart shows that while the City of Buffalo contributes 15% of its budget to support its students, Yonkers provides 34%, Rochester 24% and Syracuse, 21%.

"It is disgraceful that Buffalo Public School students receive between \$30,646,642 to \$93,151,509 less from their city than the other city school children," Rumore said.

"We call upon the mayor and Buffalo Common Council to reverse the city's unacceptable underfunding of our students and to support our students on the same level as Rochester, Yonkers and Syracuse fund their students.

"Our students deserve more, nothing less," Rumore stated.

## NEA Election Results

BTF President Philip Rumore was re-elected Delegate to the National Education Association Annual Representative Assembly June 30-July 5 in Boston, Ma.

The BTF is entitled to elect two delegates and two successors to the convention.

Treasurer Rebecca Pordum was elected as the second Delegate. The two Successors elected are Lynn Garcia and Sophia Howard - Johnson.

## Sick Bank Changes Due By June 23

Attention All Teachers: It's time to join or make changes to your Sick Leave Bank Enrollment.

Requests to enroll, change or withdraw membership in the Sick Leave Bank must be in the BTF office no later than 5 p.m. Friday, June 23.

To enroll or change the number of days donated to the Sick Bank, complete both the purple enrollment card and the grey authorization card, which are available through your building representatives.

To become a member and maintain membership in the Sick Leave Bank, a teacher must donate a minimum of two days per school year of his/her accumulated sick leave. A maximum of four days per school year may be donated. Membership in the Sick Leave Bank will be continuous without the necessity of filing a new application each year.

Teachers wishing to terminate membership must withdraw by written request. These requests must be mailed by certified return receipt requested only!! Faxed copies cannot be accepted.

## Despite Travel Cancellations, Dedicated BTF Delegates Make It To NYC For NYSUT RA

Despite bad weather in Atlanta, Georgia that caused a domino effect cancellation of dozens of Delta airline flights, BTF delegates made it to the April 7-8 NYSUT Representative Assembly in New York City.

Three delegates, Lynn Garcia, Sophia Howard-Johnson and Sue Raichilson, left Buffalo a day early to serve on the Credentials Committee at the convention. Their flight was postponed numerous times and they sat at the airport 13 hours before the flight was finally cancelled. Delta provided them with a van and driver and they drove through the night.

Meanwhile, the remaining delegates were scheduled on an early morning flight, only to have the flight cancelled. Quick thinking and action by Rebecca Pordum, presidential assistant and treasurer of the BTF, saved the day. Thirteen delegates rushed to the Depew Train Depot and caught the first train out and two others were able to catch the second train an hour later.

Three other BTF members, Delegates Kevin Gibson, Kristin Mendoza, and Mary Manley, drove to NYC.

## BTF Gets Awards At NYSUT RA

The BTF received two awards during the annual NYSUT Representative Assembly in New York City.

The BTF was awarded the Local Community Service Award, established in 1996 to recognize those locals that have made a collective and sustained contribution to community service during the previous year.

The BTF was cited for:

- Participating in many events including the Variety Club Telethon, Gospelfest and the Juneteenth Festival
- Contributing approximately \$35,000 to charities including SABAH, Inc., E.P.I.C., Shea's Performing Arts Center and Junior Achievement of WNY
- Awarding \$2,560 in scholarships to the University at Buffalo Foundation, Inc., Say Yes to Buffalo and other foundations

The BTF was also given a Lou Cammarosano Award in recognition of outstanding improvement and leadership for the 2016 VOTE-COPE Campaign. VOTE-COPE funds are used to defray campaign costs of endorsed candidates who are education and teacher friendly.

Despite the nine hour travel delay, all of the delegates and alternates arrived at the RA in time to vote in the election of officers.

## NYSUT Officers Elected at RA

BTF President Phil Rumore was re-elected Director of Election District 44 of the New York State United Teachers during the 2017 Representative Assembly.

The Representative Assembly was held April 7-8 in New York City.

Andy Pallotta, who served as Vice President under the past two NYSUT administrations, was elected to serve as president of NYSUT for the next three years.

More than 2,000 delegates attended the Representative Assembly, including 19 from the BTF. The delegates approved 35 resolutions and referred five others to the Board of Directors.

Some resolutions that passed included:

- Calling for student test scores to no longer be a mandatory part of teachers' evaluations
- Condemning computer-based testing for grades 3-5
- Opposing teacher participation in generating test questions for the state's ELA and math assessments in grades 3-5
- Supported ESSA professional development funding to be used to expand teacher center programs
- Called for NYSUT to work with national, state and local organizations to prevent US Education Secretary Betsy DeVos from any attempt to defund public education
- Called for at least 30-minutes a day of recess for all elementary school students

# Math Teacher Takes Journey Into Space

It was just about this time last year when Jorge Koury, a Math teacher at Olmsted #156, learned he had been selected to attend the prestigious Honeywell Educators @ Space Academy.

The academy, conducted at the University of Alabama @ Huntsville, was attended by 186 educators representing 30 states and numerous countries throughout the world.

The all-expense paid program was held June 16-20, and Koury says he almost missed it because the Board of Education did not want to let him go so close to the end of the school year.

The program was centered on engineering, math, science and technology. It was geared toward 5th-8th grade teachers with the intention of encouraging middle-school students to seek careers in these academic areas.

While there, the teachers spent a lot of time at the nearby US Rocket and Space Center, where the space program began. There, they met the person who started the space program and many current astronauts.

The teachers also saw where the Tom Cruise movie, Top Gun, was shot and experienced a simulated helicopter crash, which ended in the water. They also visited the control station for the 1969 moon landing.

During the program, the teachers were put into groups of 15. Koury said there were teachers from Turkey, Portugal and the Ukraine in his group and they are keeping in touch via social media.

Together they learned activities to bring back to their schools and each created his own rocket. Koury's rocket flew more than 900 feet during his demonstration. And, much to his surprise, he was able to bring the rocket home.

Koury described his adventure as "part museum, part amusement park, part school and part camp. It was an experience of a lifetime."

He said NASA has many free materials for teachers and has the capacity to take pictures from space that can be sent directly to classrooms for use in instruction.

Koury said he is hoping to share his experience, knowledge and materials with his colleagues during a half-day professional development sometime in the future.



# Schoolhouse Dems Honor Zephyr Teachout

About a dozen BTF members attended an award luncheon April 22 for Congressional Candidate Zephyr who was honored as a Defender of Public Education by the Schoolhouse Democrats.

## Extended Paychecks to Begin on July 14

If you get summer paychecks through the BTF Extended Pay Plan, the summer paycheck schedule will begin on July 14.

The final, full paycheck from the Board of Education is June 30.

Summer paychecks will be mailed to the address that is on file with the BTF as of the start of the 2016-17 school year. If you have not notified the BTF of an address change, please call the BTF at 881-5400 immediately and provide a new address.

The bank has advised us that checks cannot be cashed before the date of issue even if you receive them before that date.

**“SUMMER 2017” PAYCHECK & DEPOSIT SCHEDULE – PLEASE RETAIN THESE DATES FOR YOUR RECORDS.** (You should receive your check(s) on or before the date indicated and your deposit on the date of the check.)

- **ONE CHECK OR DEPOSIT** (One summer check or deposit to be issued) July 14
- **TWO CHECKS OR DEPOSITS** (Two summer checks or deposits to be issued) July 14, August 11
- **FOUR CHECKS OR DEPOSITS** (Four summer checks or deposits to be issued) July 14, July 28, August 11, August 25

**TO PARTICIPATE NEXT YEAR:**

- If you wish to continue participating in the BTF Extended Pay Plan next year at the same deduction per paycheck, then do absolutely nothing. The Buffalo Board of Education payroll department should automatically deduct the same amount from your second paycheck for the BTF Extended Pay Plan next school year.
- If you wish to continue participating at a different rate of deduction, you must complete a new request for participation in the BTF Extended Pay

Plan. This request must be completed on the white form specifying the “new” amount you want deducted per paycheck. Contact your BTF delegate or the BTF office for the form. This form must be received at the BTF office by Friday, August 25, 2017.

- If you do not wish to continue as a participant for the 2017-2018 school year, you must notify the BTF in writing before August 25, 2017. This letter must give your authorization for withdrawal from the BTF Extended Pay Plan effective September, 2017 through June, 2018.

To keep our records and the bank's records accurate and up-to-date, and provide sufficient time for our accountants to review the accounts, there can be no withdrawals after June 1 (of each school year) unless there is an emergency situation explained and verified with appropriate documentation.

**DIRECT DEPOSIT:** Please remember that if you have made any changes to your checking account during the 2016-2017 school year **YOU MUST** notify the BTF before June 1st to ensure that your deposits are made correctly. Providing the BTF with a voided check is the best way to update your account information, but you may also call the BTF, (716) 881-5400.

**\*REMINDER:** BTF will continue to offer Direct Deposit for your Extended Pay Plan Funds through Northwest Savings Bank to the bank of your choice. If you have not done so, please complete the bottom of an Extended Pay Plan card and submit a **VOIDED** check for the account that you wish the funds to be directly deposited.
